Social Housing in Asia: from advocacy to experiment

Section 1

Background:

Since 2012, Hong Kong faced declining housing quality and housing unaffordability issues. The Government had no alternative ways to increase more public rental housing due to the shortage of usable lands and the increasing housing demand. In civil society, the housing working groups calls on the government to set up rent regulation. Some request to the government to make use of idle private housing units or land. The government did not accept the proposal on rent regulation, but commissioned the Hong Kong Council of Social Service to coordinate the supply of "transitional social housing" and to engage NGOs to operate social housing with services in late 2017. Yet, the radical housing group criticizes the government about shifting her responsibility for tackling housing problems to civil society and call on the government to do it on her own.

Section 2 Background:

Taiwan has started to provide social housing since 2010 due to a long-term housing movement. Since 2016, President Tsai promised to complete 200,000 units, about 2% stock before 2024. Section 3

Background:

Korea Land and Housing Corporation owns 1.1 million public rental housing units. The types of rental housing cover a relatively wide range of income groups but about 40 percent of them are extremely very poor. So we have been supporting a various housing-based welfare services since 2017 to improve their quality of life and enhance social mobility.

LH has been a hardware-centric supply and physical management, but we have recently recognized that tenant-centric software programmes are very important for the elderly, single parents, children and another disadvantaged groups. So we provide housing services such as health care, education, child care, housing counseling and job training. These services are very diverse. Thus LH organized it into three categories -assisted living services, community services and platform services- and invented the brand 'Rainbow housing services'. Ms Jin Meeyoun will introduce the recent development of public housing services.
